1. TERMS, CONDITIONS, RULES AND REGULATIONS

SUBMISSION

1. Applications are open to young people from ages 12 to 20. Applications can be made by individuals or by groups. (A group could be, for example, a class/year group, a youth group or a club, or simply a group of friends who wish to submit a joint entry).
2. Applicants under the age of 18 should have their entries countersigned by a responsible person over the age of 18 (for example, a teacher, youth group leader, parent, guardian, family member).
3. By submitting your film to the competition you are agreeing to be bound by the Competition Rules and Regulations.
4. Submissions will be received by the ICCL from 26 January 2012 onwards, until the deadline of **Wednesday 9 May 2012**.
5. The film should a **maximum of one minute** in length.
6. The film can take any form, be it live action, animation, fiction, drama or documentary. It must be on a human rights theme.
7. Human rights are all about respecting yourself and other people. Any entry which speaks about or treats people in a disrespectful way will be immediately disqualified.
8. The film can be made on any portable digital device, such as a mobile phone, digital camera or camcorder. The resulting film quality may be taken into consideration when the ICCL shortlists submissions.
9. Along with the film, submissions must contain all required material, as outlined in the Competition Outline and Application Pack. Incomplete submissions will not be considered.

10. Submitted films must be provided on disc. This can be a standard playable DVD, or as a standard QuickTime/WMV/flv/Real Player file on a CD ROM/ DVD. Please ensure that submitted disks are tested in advance of sending.

11. The deadline for sending of submissions is **Wednesday 9 May 2012**.. We will accept submissions if the postmark is **Wednesday 9 May 2012**.at the latest, or if the submission is brought to the ICCL's Dublin office by 5p.m. on that date. The ICCL Human Rights Film Awards cannot guarantee the consideration of any applications sent after this date.

SELECTION

12. The ICCL panel will choose a shortlist of four films on three primary criteria:
 - The filmmaker's display of human rights awareness,
 - The effective presentation of the chosen human rights issue,
 - The quality of the film.

13. The shortlist of four films will be posted on the ICCL's Vimeo or You Tube webpage and will be put to a public vote. This will be promoted on Facebook.

NOTIFICATION

14. The winning filmmaker will be notified by Monday 21 May 2012

THE PRIZE

15. The winning film will be featured on RTÉ's Two Tube TV programme and website in May 2012. It will also be showcased at the ICCL's Human Rights Film Awards Gala in summer 2012.

16. Further prizes may be provided to the winner – details will be made available on the competition website (www.humanrightsfilmawards.org) in spring 2012.

2. CHECKLIST FOR ENTRANTS TO THE 2012 ICCL HUMAN RIGHTS IN UNDER A MINUTE CHALLENGE

All submissions to the 2012 ICCL Human Rights in Under a Minute Challenge should include the following:

- 2 copies on DVD or CD of the film in a format specified in the Rules and Regulations
- A completed application form, including a description of the project, at a maximum length of 300 words. This description should detail the film's human rights focus and the filmmaker's reasons for choosing the subject.
- If the applicant is under 18 years of age, the application form should include the details and signature of a responsible person over the age of 18 (for example, a teacher, youth group leader, parent, guardian, family member).
- Any other support studies, storyboards or photography relevant to the film.
